
and we did indeed save the baby! We ended our journey by sharing a nice meal together.

Sue opened the session with prayer.

This meeting was called to allow those council members not in attendance at the February 4th meeting with Leon Wlazlo to hear his proposal regarding the Church Windows configuration.

Pastor Ed shared that Leon's proposal would use Leon Wlazlo's expertise and allow him access to work with the Treasurer, the Finance Team Chair, and any other staff member of the church during

scheduled hours to reorganize the Church Windows system so that our budgetary work could happen without any more difficulty and confusion within the system.

Question regarding a consultant's fee: *No, Leon would do this for free*. Also further clarification was needed for some council members to make a decision. If there were any concerns at all, they are to be taken to Pastor Ed for clarification and mediation.

Motion to accept Minutes submitted by Susan Bennett, Council Chair, following February 20 Council meeting: Matt Wightman motioned to approve as amended, Sandy Dodd seconded. All in favor.

Windsor United Methodist Church (WUMC) 56 Chapel St., PO Box 36, Windsor NY 13865 Special Church Conference—February 26, 2024

This special session of the church conference was scheduled by our DS, Rev. Bob Kolvik-Campbell to present the Resolution to Sell the church parsonage.

Present: The Rev. Bob Kolvik-Campbell, District Superintendant of the Binghamton/Oneonta District, Pastor Ed Honrath, the Rev. Ron Wenzinger (representing the District Committee on Buildings and Grounds), John McNulty, Chair of the WUMC Board of Trustees, and 40 members of the WUMC congregation.

The meeting was called to order at 6:30pm with Pastor Ed leading us in prayer.

Pastor Bob explained the voting rules that only professing members of the church are able to cast a vote. He handed out the document *Church Conference Resolution To Sell the Parsonage of the Windsor United Methodist Church.* He presented and read each of the 7 resolutions. Items 5 and 6 referenced the 2016 United Methodist Book of Discipline with regard to consent of the District Board of Church Building and Location and the Binghamton DS, along with the Restriction on Proceeds of Mortgage or Sale. A copy of the resolution document accompanies these minutes.

Also presented to the members by John McNulty, was a summary of the Offer to Purchase the property at 25 Academy St., Windsor NY. This summary detailed the terms of the purchase and the pending offer of \$140,000 with a final balance at closing. John explained that the final contract would then go through the attorney general's office. We will also need to hire our own lawyer (approx. \$2,000), which John has secured. This document also accompanies these minutes.

The floor was open for questions:

1. Explain the circumstances for which the monies from the sale can be used. Described in the Book of Discipline paragraph 2543 as referenced above.

Pastor Bob explained that a housing allowance is provided to any future pastor who may need housing. Church Council's task will be to discuss and create a plan for this.

There is a parsonage with the Sanitaria Springs UMC, which allowed the conference to consider its decision to approve the sale of ours.

2. If our donations and Sunday School attendance are increasing, why wouldn't we be favoring a FT pastor in the future?

Pastor Ed provided a document as requested by Council outlining the attendance and income from 2018 through 2023. It is unlikely we will afford a FT pastor based on current attendance, donations received and our income.

3. Income rental vs. what we can spend the monies received from the sale. Why can't we keep renting the property?

John McNulty explained that the repairs are extensive and the church cannot afford to pay for them. Expenses to keep it heated, etc. when it was empty were more than expected. It needs an entire new roof, and both porches are in need of extensive repairs. The current tenant has not asked for much and has and is willing to take care of many minor repairs with Trustee approval.

Pastor Bob re-emphasized having a plan in place to establish housing for an incoming pastor's need.

John also mentioned that the Board of Trustees feel their concentration is focused on keeping our church building and grounds in good repair and energy efficient.

4. A member asked why the roof replacement cost is so high. Pastor Ed again explained the repair costs vs. the monies available to do said repairs.

Pastor Ron explained the decision that the Committee on Housing and Grounds has heard based on our situation and is supportive of this decision. He also assured us that they are a good support resource.

After hearing from several other members regarding not living in the "what if's", but to move forward and continue with our discipleship making, Pastor Bob led us in prayer.



The Resolution to Sell the Parsonage was accepted and the Trustees can proceeded with the contract offer.

# Church Conference Resolution To Sell the Parsoange

# Windsor United Methodist Church 26 February 2024

- Whereas the Windsor United Methodist Church received permission from the Bishop and Cabinet of Upper New York Annual Conference to place the Windsor UMC parsonage for sale, and
- Whereas the Parsonage is not being used to house the pastor serving the church at this time, and
- Whereas an offer to buy the Windsor UMC Parsonage has been received and reviewed by the pastor and the Board of Trustees of the church, and they believe it is a viable offer for the parsonage, and
- Whereas the Board of Trustees and the Church Conference of the Windsor UMC have evaluated the offer, and
- 5. Whereas the Board of Trustees and the Church Conference of the Windsor United Methodist Church understand and will comply the process, outlined in paragraph 2539 and paragraph 2541 of the 2016 United Methodist Book of Discipline which includes consent of the District Board of Church Building and Location and consent of the Binghamton District Superintendent, and
- Whereas the Board of Trustees and the Church Conference of the Windsor United Methodist Church understand and will comply with paragraph 2543 of the 2016 United Methodist Book of Discipline, regarding Restriction on Proceeds of Mortgage or Sale,
- 7. THEREFORE, the Church Conference approves the sale of the Parsonage of the Windsor United Methodist Church and directs the Board of Trustees to proceed under the aforementioned paragraphs of the 2016 United Methodist Book of Discipline, outlining the process and limitations on the proceeds of said sale.

#### Board of Trustees Report of the Work In 2023—reported by Geri Tow, Trustee Treasurer

2023 Officers: Chairman, John McNulty: Vice Chairman, Norm Quinn: Secretary, Keith Royer: Treasurer, Geri Tow; other members: Tom Birtch, Bob Bode, Matt Wightman.

The parsonage was rented to Amy Willett with the approval of the church council in February.

Replacement of the electrical system of the church was required because there had been significant water damage over the course of time.

The trustees explored the possibility of installing Mitsubishi heat pumps for heating and cooling the church to supplement the boiler. This provides an environmentally improved and less expensive option for the church. With the church council approval, they secured funding from the Sherwood Trust/ Wilmington Advisors at M&T Bank for \$26,000. With the help of Matt Wightman, the cost of the four H21 heat pumps were greatly reduced. Two heat pumps are installed in the sanctuary, one heat pump in fellowship hall and one heat pump in the nursery section of the building. John McNulty and Matt Wightman supervised the installation.

The carpet was professionally cleaned in fellowship hall and the narthex.

A walk through of the parsonage was completed along with the SPPR committee and the appropriate form was submitted to Conference.

September school taxes for the parsonage were paid from the parsonage rental account. The renter has informed us that she is eager to purchase the house and the church council has approved the sale. The District Superintendant has informed us that there is a process which we need to follow for this to happen. He also stated that the proceeds from the sale of the Parsonage cannot be used for general operating. Only and of the interest from the proceeds is available to the church.

Some patching was done on the parking lot where most needed. The parking lot is in need of additional repairs in the future should funds become available.

The trustees decided that outside doors have deteriorated to the point that they needed to be replaced. The doors have been repaired with metal plates in the past. The estimate for the 10 double doors and two single doors is \$35, 301. After some discussion and approval by church council, the request was made to the Sherwood Trust/Wilmington Advisors at M&T bank trust fund. The doors have been ordered at a lesser cost than we expected and they will be replaced as soon as they arrive.

We have been evaluating the assets of the church for insurance purposes and will soon have a report.

Many repairs have been completed over the course of the year by members of the Trustees Committee, to keep the building in good shape and we can all be thankful for their efforts.

The trustees have worked on a budget for 2024 with the hope that the most expensive projects are behind us.

#### Report from Matt Wightman, WUMC Board of Trustee Member

Last winter 2022-2023, we were primarily heating the church with fuel oil and keeping the unoccupied temperatures set around 50F to 55F. At that temperature we still used over 1200 gallons of fuel oil for the winter. For the 2023-2024 winter based on the fuel oil usage the previous winter, Mirabito recommended pre buying 1200 gallons of fuel oil at \$4.20 a gallon. This would amount to \$5,040.00 worth of oil. This year we used the 4 heat pumps for as much heating as possible. During extremely cold

weather we supplemented with some oil to raise the temperature. According to the gauge on the tank we have used just under 1/4 of a 275 gallon tank or approximately 68.75 gallons. This would amount to \$288.67. As of 3/28 we have used 17,478 kWh of electricity to run the heat pumps. At an average of approximately \$1.15 per kWh. We have used approximately \$2,621.70 for heat pump operation.

We have maintained the church at a minimum of 65 degrees which makes it more comfortable when typically unoccupied. So far this is a significant savings over what we would have spent for heat this winter. We are continuing to monitor and find ways to minimize the use of resistance electric heat on the Sunday School and office side.
